### **CODE OF CONDUCT**

**BOUNDARIES OF CODE:** Any member of the Association (playing or not playing) at any Association event is bound by this code.

**BEHAVIOUR:** No smoking, drinking or eating over pool tables. No sitting on tables. Tables, cues, balls and any other equipment being borrowed from a venue are to be returned in the same condition as they were in when they were received. Any damaged equipment will need to be paid for by the person responsible for the damage.

**VENUES:** Members will respect and obey the individual venues rules and wishes during all Association events. Any wilful damage caused by a member to a venue will need to be paid for by the person responsible. No illicit drug use or BYO of alcohol permitted on venue grounds. Any incidents occurring at a venue outside Association events are in no way to be the responsibility of the Association. "If a breach of this conduct is found, the member will be asked to leave the venue immediately and disciplinary action will be advised by a future dated committee hearing".

**MEMBERS:** The Association constitution and by-laws will be observed at all times.

**THE INTERNATIONAL 8 BALL FEDERATION RULES:** As stated in the rules, the individual player is responsible to know the rules. In the event of a dispute, if a recognised accredited umpire is available and not playing in a game, they make the ruling. If not available, the two captains will make the ruling.

**SPORTSMANSHIP:** All games will be played in good spirit and sporting manner; the rules of the game and Association by-laws will be observed at all times.

### **CONSENT CONTACT DETAILS & PHOTOS**

Peel Pool Association collects members contact details including mobile numbers and email addresses to assist in the planning of Summer and Winter Competitions. Mobile numbers are released to the captains to enable them to organise the teams' activities.

During competitions photos are taken and used for promoting the Association on the Peel Pool Association website and Facebook pages.

Members are encouraged to notify the secretary if they do not consent the use of their photo or release of their contact details for planning team purposes.

### **MEMBERS MUST ABIDE BY THE CODE OF CONDUCT AT ALL TIMES!!**

Association control of a member will commence 30 minutes prior to the fixtured start time and will cease when the member leaves the premises (i.e. car park, premise boundary). Breaches of the PPA Code of Conduct will result in disciplinary action issued by the Committee of the Peel Pool Association.
